



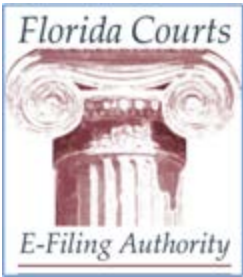

# ePortal Usage Statistics



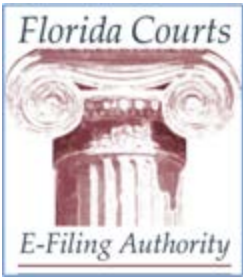

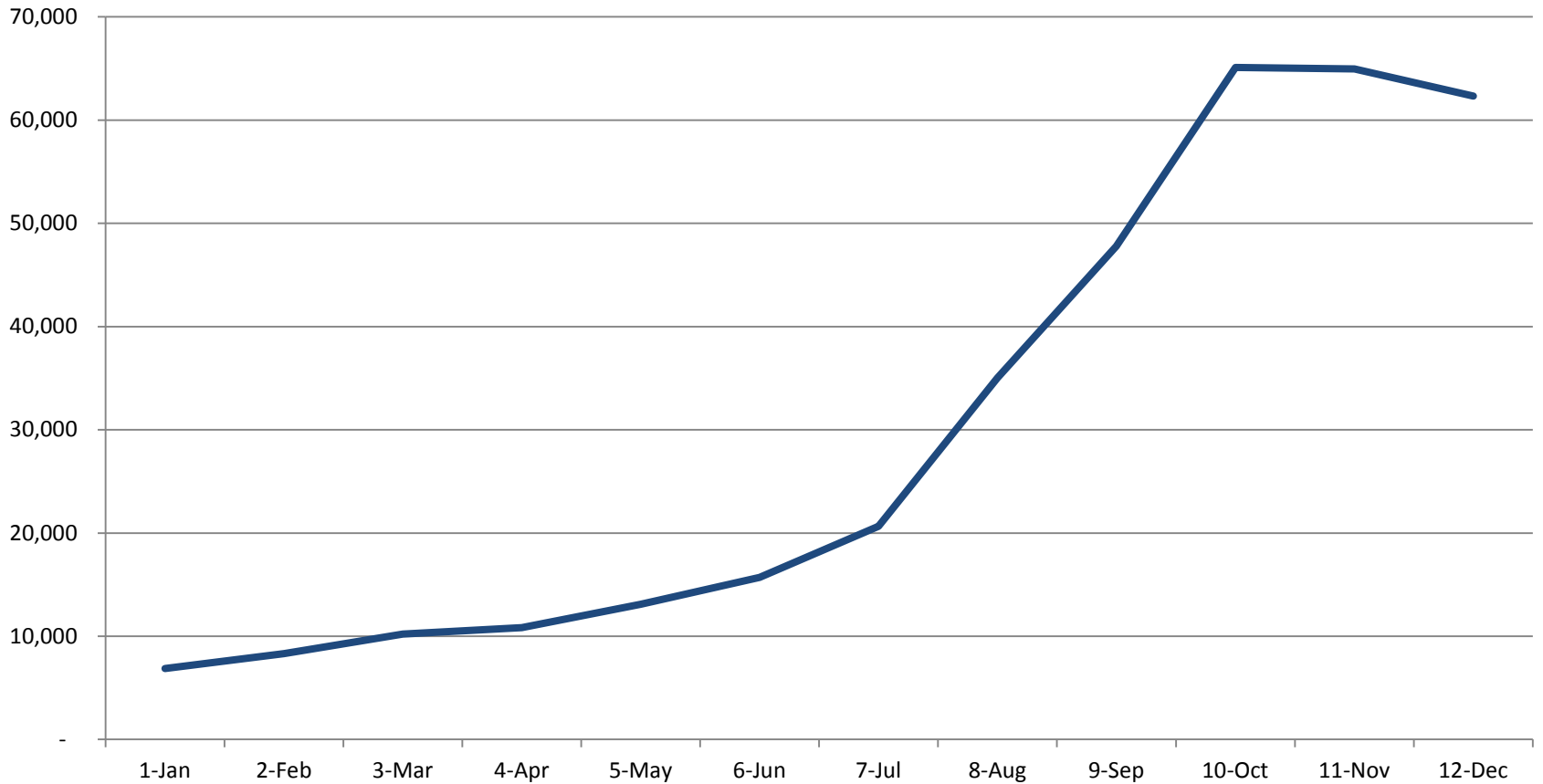

## 2012 eFilings by Month

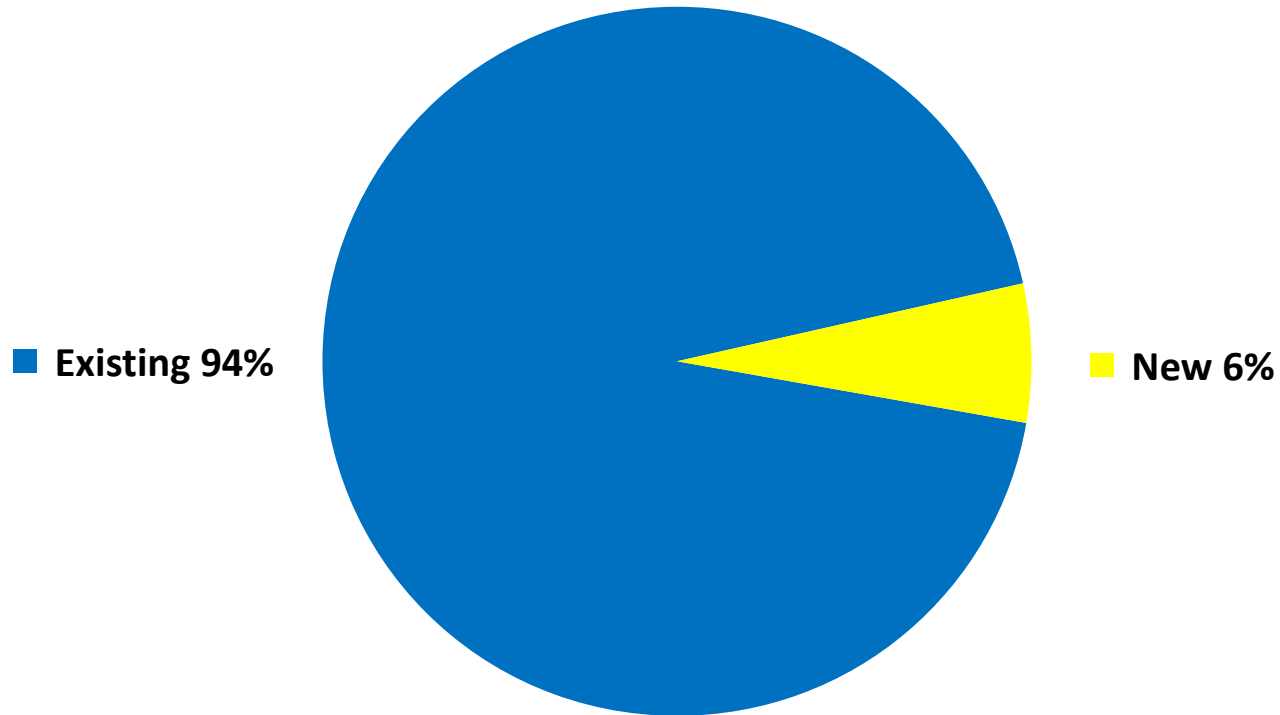


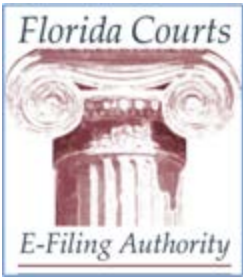

## 2012 eFilings by Type of Case

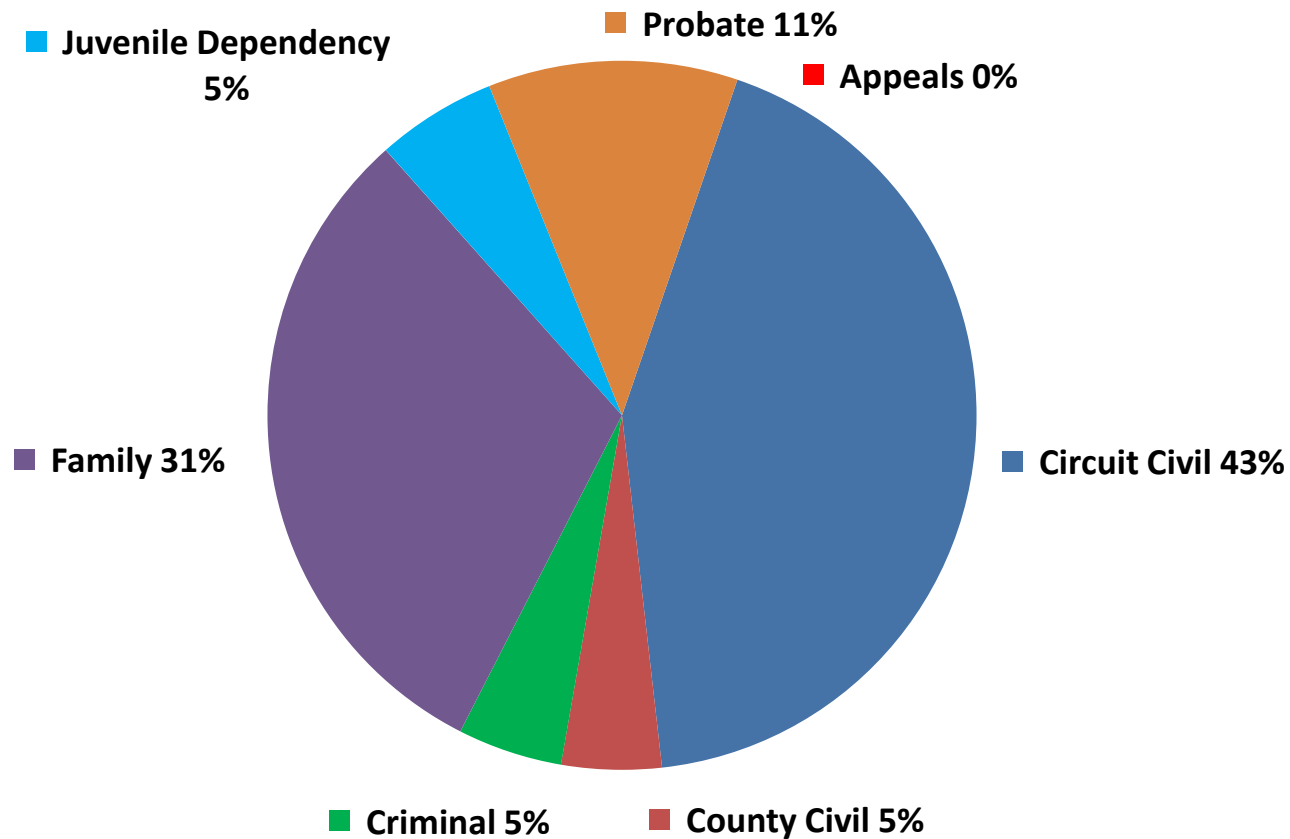

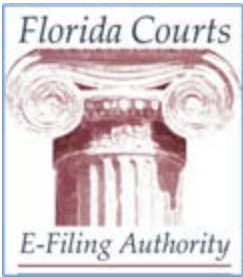
