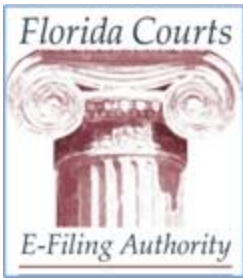

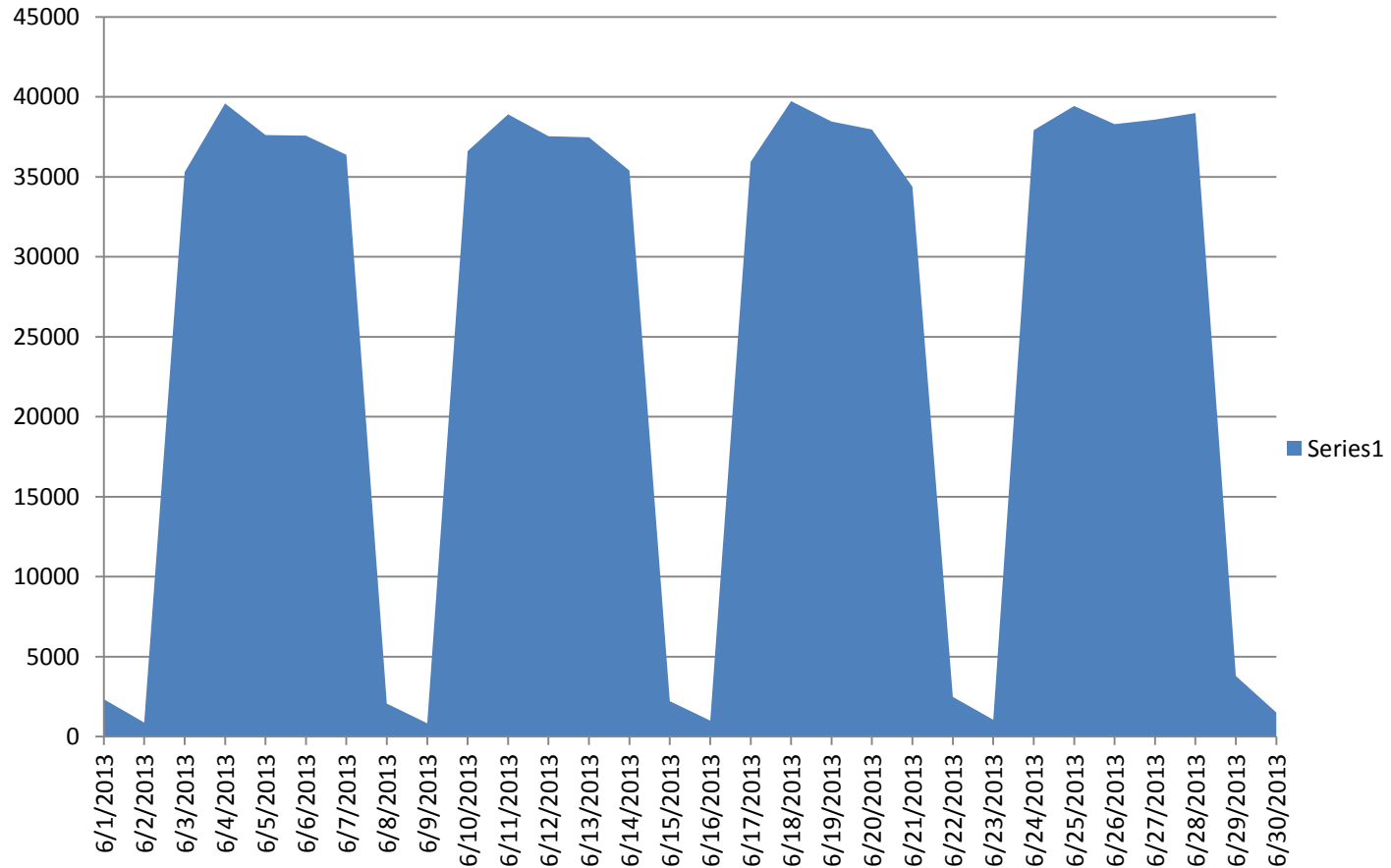

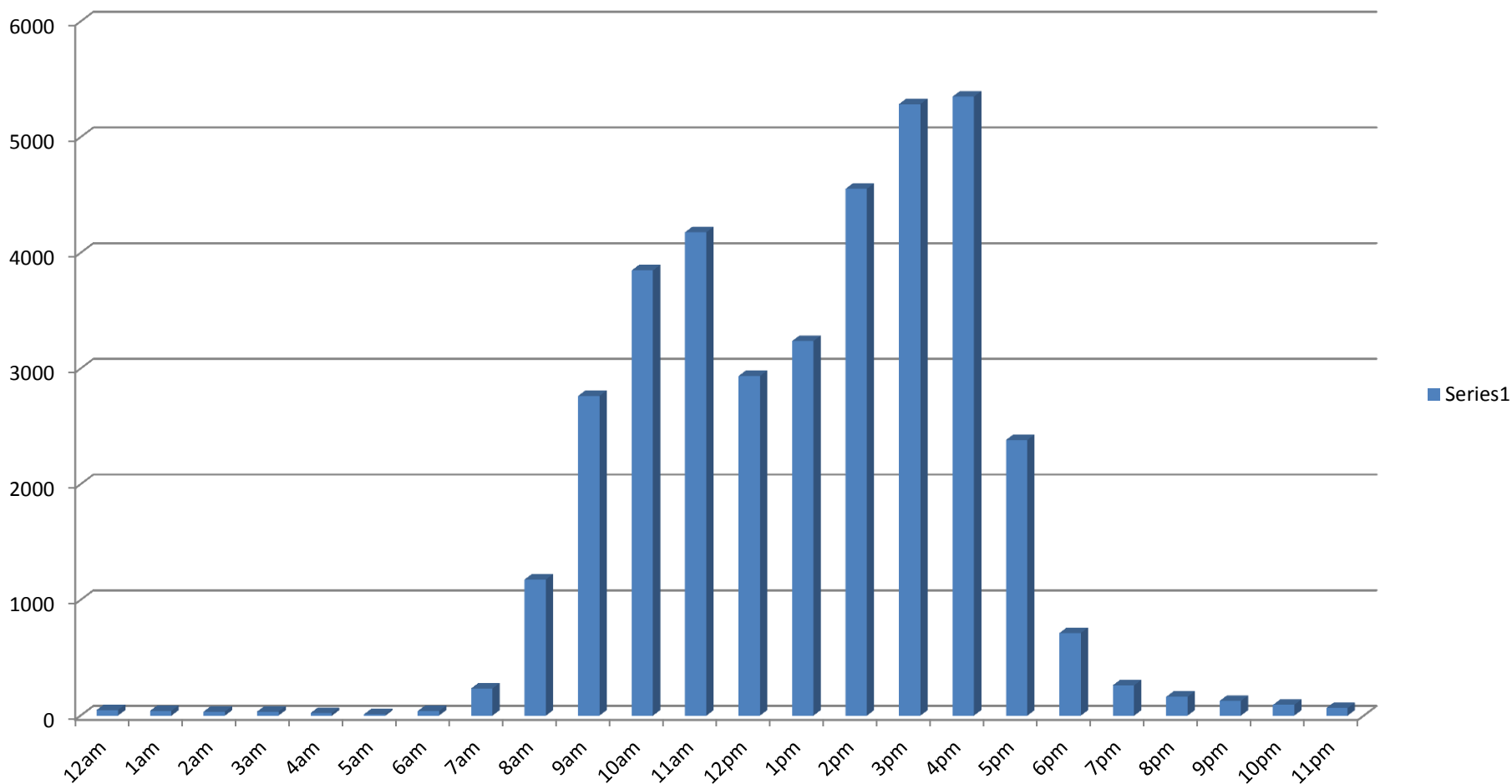


June E-Filings By Day
