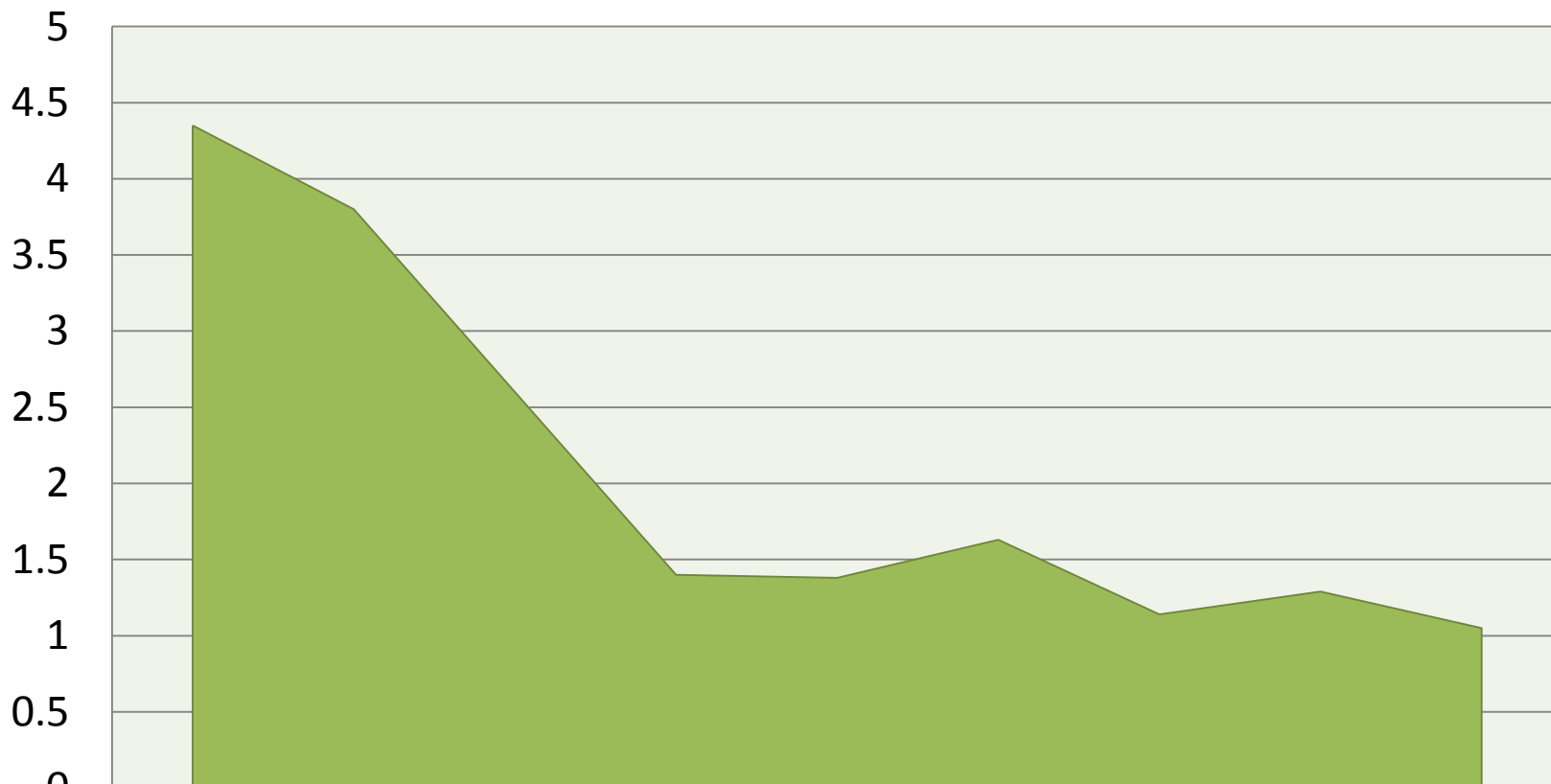
E-Filings Sent to Pending Queue
